From Pastor Gary Kinkel...

Dear Sisters and Brothers in Christ,

Summer is here, and the weather is hot! Gardens are in, plans are made for getaways, outdoor activities beckon and we enjoy lakes, parks, art festivals and a host of other things. All these good things are from God who made them and gave them to us as gifts. God delights in them and wills that we should, too. It is so easy to step from there to the view that we should do whatever we want to do with the natural world. We talk and act as though the world is ours to do with as we please. But that is not what God wills. The creation accounts (there are two of them) in Genesis teach, as the great theologian of the Old Testament, Gerhard von Rad, wrote, that human beings are created to "tend God's garden" in God's name and for God's sake. We are not created to use the earth (God's garden) in our name and for our own purposes. No. We are called to represent God before the earth and to care for it, and all its creatures, in God's way and according to God's will.

The reality of sin in its cancerous malignancy disrupts and destroys our relationship to God, our relationships with each other, with ourselves and with the natural world. Therefore, it is not merely "souls" that are lost and need to be saved. The whole world is broken and in need of saving. Indeed, the old song by Bob Dylan is a true statement about the world: "Everything is Broken." In fact, we, and all else, are so broken, we are so far gone, that we do not even see the brokenness. We do not note our own sickness. And until we know we are desperately sick, we will never seek healing and salvation.

The Church is here, in the summer, too, calling out the Word of the living God. Calling us to account for our sin and announcing God's saving, healing grace. But without that Word we cannot even see things in the right way, cannot think in the right way about ourselves or the rest of the world. This summer I am preaching a series of sermons on the character of God. Who is the God we worship? How is God the All Determining reality in the universe? Please make sure to be here so you can come to know God better, love God more deeply and see things more clearly and truly. Without this preached Word we quickly lose our way AND our vision.

I'll see you this summer!

We rejoice when we are suffering and when we are happy; we rejoice when we are busy and when we are on vacation; and we rejoice when we are at home and when we are far away. We do this so that we might abide in the one who has died in order to set us free. St John's Evangelical Lutheran Church Council Meeting Minutes March 13th, 2018

Gathering

The March 13, 2018 meeting was called to order at 7:00 PM by Nancy Berndt. Shelley Gehrman agreed to be the timekeeper. Scott Wilts made and Pastor Gary seconded a motion to approve the agenda.

Pastor Gary led the council in a continuing study of the book of Acts, highlighting verses 8-15 of Chapter 6. He pointed out that even though Steven was not an apostle, he acted like one. Like Jesus, Steven did not respond to the accusations of blasphemy leveled against him by false witnesses. We find similar behaviors in our churches today in that people who are not strong enough to stand up for their beliefs agitate others into action.

Discernment - The following topics were presented:

- A. <u>VBS</u> Good Earth Village will run a full day program called Day Camp Plus. There will be a ratio of 8 campers per counselor.
- B. <u>Spring Social Update</u> Jenny Pudwill made and Aimee Johnson seconded a motion that all funds from the silent auction, live action, raffle, ticket sales, and games be distributed as follows: 100% to the Fund in Need--designated for our Children, Youth and Family Ministry. Motion carried.
- C. <u>Fundraising Activity</u> Council members agreed that sponsoring "Bingo Night" at the Brew Hall in Shakopee would be a fun and well-attended activity. No date for the event has been determined.
- D. Executive Committee Meetings There may no longer be a need for this committee to meet. The council will address the topic at its upcoming retreat.
- E. Easter Worship-Community Worship Ads should be placed in the newspaper alerting and inviting the public to our church activities.
- F. <u>Church Pew Inserts</u> Scott Wilts presented samples of pew inserts that would benefit both members and visitors worshipping at St. John's. One insert could say "I give electronically." A second could identify a prayer request. Pastor Gary would like a third pew insert developed that would address Lutheran worship specifically.
- G. Church Fellowship Area Updates It is hoped that additional chairs and other amenities will be in place by Easter.

III. Decisions (Old Business)

- A. <u>Motion to approve council minutes</u>: Council members will receive a copy of the February minutes via e-mail. Each will let Nancy know of either his or her approval or any necessary additions or corrections to be made.
- B. <u>Reports</u>: There were no questions regarding written reports from Pastor Gary, Pastor Jerod, Council President, or St. John's Team Leaders. Erik Allen sent the Treasurer's Report via e-mail. Jenny Pudwill made and Nancy Berndt seconded a motion to approve the report as printed. Motion carried.

IV. Sending - The next council meeting is at 7:00 PM on April 17, 2018. Tonight's meeting closed with prayer and was adjourned at 8:40 PM.

I. Gathering

- A. The meeting was called to order at 7:04 PM by Nancy Berndt. Renee Lea agreed to be the timekeeper.
- B. A motion to approve the agenda was made by Kathy Larson and seconded by Renee Lea. Motion carried.
- C. Pastor Gary led the council in a continuing study of Acts 7:1-8. Although it appears the main character in Stephen's story is Abraham; in truth, Stephen is preaching about Jesus. Council members agreed that Jesus remains the only savior here at St. John's Lutheran Church.

II. Discernment (New Business)

A. Council Retreat: is set for April 28th from 9:00 AM until 1:00 PM here at the church. Focus topics will include:

- Maintaining open and transparent communication
- Setting council goals
- Determining need for/purpose of Executive Council
- Energizing the congregation
- B. Pastor Jerod's Installation:

Pastor Jerod will be installed at each of the services on April 22, 2018. All members and friends will be invited to the reception scheduled between the two services. Aimee Johnson will co-ordinate all food and decoration responsibilities for the event. Pastor Jerod reminded council members to honor God rather than him during this memorable occasion.

C. Vacation Bible School:

Renee Lea made and Nancy Berndt seconded a motion to schedule VBS for August 6 – August 10 from 9:00 AM until 4:00 PM. Motion carried. The cost per child will be \$60 with financial and contractual details to be determined at a later date. St. John's church will provide lunches for camp counselors each day and provide lunch for all campers on August 10th as well.

D. Synod Assembly Delegation:

Pastor Jerod, Pastor Gary, and 3 lay members of St. John's will attend the Synod Assembly. Nancy Berndt made and Jenny Pudwill seconded a motion to pay all registration fees out of St. John's budget. Motion carried.

E. Youth Gathering:

Jenny Pudwill made and Aimee Johnson seconded a motion to pay all Pastor Jerod's out-of-pocket expenses for the youth gathering in Texas. A discussion was held regarding already completed events and future fundraising plans to offset expenses for attending the gathering. Envelopes for donations are posted in the entryway. Funds are available from the MWAM Bake Sale and Spring Social; and a Bingo Night will be held at the Shakopee Brew Hall.

III. Decisions (Old Business)

A. Council Minutes:

February 2018 Council Minutes were amended to clarify that all funds from the Spring Social would be awarded to Youth Ministry at St. John's—50% to the Sunday School and 50% to be divided between expenses for the Youth Gathering and expenses for Vacation Bible School. This represents a different allocation of funds from that of past years.

B. <u>Treasurer's Report:</u>

Erik Allen reported that we have \$65,000 in the checking account. At present we are at 99.5% of projected giving—leaving us slightly ahead of our budgeted deficit funds. Shelley Gehrman made and Aimee Johnson seconded a motion to approve the budget. Motion carried.

C. President's Report:

Pastor Gary Kinkel's performance review will be held during the month of May. Reviews for Sean Vander Veen, Karen Van Sickle, and Mitch Evett will be scheduled during the month of June.

D. Team Reports:

Sunday School students and their friends, teachers, and families will be going bowling during the month of May.

IV. Sending

- A. Newsletter Report: Shelley Gehrman will write an article for the May issue of the newsletter. Aimee Johnson will write an article for the June newsletter.
- B. Council members held hands and prayed the Lord's Prayer together.
- C. Jenny Pudwill made and Shelley Gehrman seconded a motion to adjourn. Motion carried. The meeting was adjourned at 8:25 PM
